

VERIFY YOUR BOND: USER INFORMATION

Purpose

This guide is designed to serve obligees who may want to verify the authenticity of surety bonds they are being asked to accept. The most reliable way to authenticate a surety bond is to contact the issuing surety company directly. However, it is often difficult to ascertain the correct address, telephone number or person to contact at the surety. Accordingly, this guide contains a list of surety companies that have volunteered to be included together with information as to how they can be contacted for the purposes of authenticating a bond. Since participation in this program is voluntary, not every surety company is listed.

If A Company Is Not Listed

If a company is not listed, the obligee might want to consider other information sources such as the telephone directories, the State Insurance Department, the Federal Treasury List, Best's and/or insurance agent or broker. If these sources fail, users of this guide are welcome to contact the Surety & Fidelity Association for assistance.

When To Inquire

The effort to authenticate a bond should be made immediately after the bond is presented. However, when making any inquiry it is important to recognize that it may take a few days for the surety to respond. Surety bonds are frequently executed by agents or in field offices of the company. Often it takes a few days before a newly executed bond is entered into the data processing network or is reported to the supervising office. However, if an inquiry is not answered within two weeks, a follow up might be suggested.

Cross Referencing

Several of the surety companies listed in this guide are members of a group of companies which have common ownership. If all inquiries for companies in the group are to go to one particular company, the listing in the guide will refer the user to the appropriate related company where the inquiry should be directed.

Information Needed

When making an inquiry to authenticate a bond at least the following information should be provided: (The best way to supply this information is to enclose a photocopy of the bond with your inquiry.)

1. Bond number (if any).
2. Name and address of principle (including all of the names of the parties if the principal is a joint venture).
3. Name and address of obligee.
4. Amount of Performance Bond.

5. Amount of Payment Bond.
6. Date bond executed.
7. Name of person signing bond for the surety.
8. Brief description of project.
9. Contract price.
10. Directions as to whom the confirmation should be sent.

In lieu of submitting a photocopy of the bond, a suggested format for supplying this information is included with this guide. Users are invited to copy the format for use in making their inquiries. [Click here for the form.](#)

NOTE: When making an inquiry, the best result should be obtained by using the number 1 inquiry method specified by the particular company to which the inquiry is being directed. When a method of preference is indicated, the primary or preferred method is shown as number 1, the second preferred method is shown as number 2, etc.

Check Name

The name of the surety company appearing on the surety bond should be identical to the name of the surety company appearing in the guide. If there is **any** discrepancy, that fact should be called to the attention of the surety company when making an inquiry.

Note: This Guide should not be relied on as an indication as to the solvency or financial strength of any of the surety companies listed. Users that are interested in determining solvency or financial strength should consult other resources such as state insurance departments, A.M. Best Company, insurance agents and brokers or other sources of such information.

VERIFY YOUR BOND: SURETY COMPANIES - WHAT THEY ARE AND HOW TO FIND OUT ABOUT THEM

Corporate surety bonds are the preferred method of guaranteeing the performance of financial obligations of others. These guarantees include contractor performance and payment bonds, financial guarantee bonds, license and permit bonds and many others. More and more companies, public officials and individuals need to find out about the companies that issue the surety bonds that protect them, but may not know where to obtain this information.

This section outlines information sources available to those who seek financial and other data about companies that issue surety bonds.

What Is A Surety Company?

Most large property and casualty insurance companies have surety departments. In addition, there are some companies for which surety bonds make up all or most of their business.

In either case, in order for a company to write a surety bond in the United States, it must be licensed by the insurance department of one or more states. While there are some exceptions, generally a surety company is required to be licensed by the state in which it is doing business or by the state where the obligation guaranteed by the bond is being performed.

INFORMATION SOURCES

The following are sources of information on surety companies.

Insurance Departments

Since companies that write surety bonds must be licensed by the state insurance department, an obvious source of information is the insurance department itself. The insurance department of the state in which the surety company is domiciled will usually have the most information about the surety as it is responsible for performing periodic examinations of the company. Insurance departments are located in the state capital and, in some instances, have offices in larger cities of the state. The telephone numbers are usually found under the state listing in the local telephone directory. Insurance departments are generally responsive to consumer inquiries, and any citizen may call the department and request to speak to someone who can provide information on a particular surety company.

U.S. Treasury Department

The United States Treasury Department maintains a list of surety companies that it has qualified to write surety bonds required by the U.S. Government. This list is published in the Federal Register once a year on July 1. The Treasury Department requires companies that desire to be included on its list to file financial and other information. This data is analyzed by the Treasury Department which develops a dollar Underwriting Limitation for the company which is shown for all companies included on the list. However, it is important to recognize that a surety may

provide a single bond with a dollar limit that exceeds the limit appearing in the Treasury List. When the Underwriting Limitation is exceeded, the surety must be protected in accordance with the following rule which appears as note (b) in Treasury Circular 570:

(b) The Underwriting Limitations published herein are on a per bond basis. Treasury requirements do not limit the penal sum (face amount) of bonds which surety companies may provide. However, when the penal sum exceeds a company's Underwriting Limitations, the excess must be protected by co-insurance, reinsurance, or other methods in accordance with Treasury Circular 297, Revised September 1, 1978 (31 CFR section 223.10, Section 223.11). Treasury refers to a bond of this type as an Excess Risk. When Excess Risks on bonds in favor of the United States are protected by reinsurance, such reinsurance is to be effected by use of a Federal reinsurance form to be filed with the bond or within 45 days thereafter. In protecting such excess risks, the underwriting limitation in force on the day in which the bond was provided will govern absolutely.

The Treasury List (Department Circular 570 - Surety Companies Acceptable on Federal Bonds) may be obtained from the Surety Bond Branch, Financial Management Service, Department of the Treasury, 3700 East-West Highway, Room 6F04, Hyattsville, Maryland 20782 (telephone number 202-874-6850). Either the National Association of Surety Bond Producers (202-686-3700) or The Surety & Fidelity Association of America (202-463-0600) will provide information on whether a specific company is included on the list and the amount of its underwriting limitation.

A.M. Best Company

A.M. Best Company (Best's) Ambest Road, Oldwick, New Jersey 08858, is a private publishing company that analyzes and rates insurance companies. Each year Best's publishes Best's Insurance Reports, Property-Casualty, which includes a detailed profile of almost all insurance companies operating in the United States as well as financial information about each company. Best's gives each company an alphabetic rating and a financial size category. This book, which is over 2,300 pages in length, may be found in many public and financial libraries. It may be purchased from Best's at a cost of approximately \$525 and would be useful for those who have occasion to accept numerous surety bonds. Best's also publishes a much abbreviated version of this information in its Best's Key Rating Guide, Property-Casualty, which costs approximately \$100 and contains the alphabetic ratings and financial size categories. Best's will not send out information to inquirers who do not subscribe to either publication and under no circumstances will they divulge rating information over the phone.

Insurance Agents & Brokers

Most surety bonds are issued through insurance agents and brokers who in many instances can provide much information regarding a specific surety company. Professional agents or brokers specializing in providing surety bonds will often have the U.S. Treasury Department Circular 570 and the Best's Insurance Reports, Property-Casualty. In addition, they may be able to assist in reviewing surety bonds for proper execution. Names of agencies specializing in surety bonds may be obtained from the [National Association of Surety Bond Producers](#).
